In addition to managing charitable contributions on behalf of donors, the Mt. Pleasant Area Community Foundation serves Isabella County through the awarding of grants to charitable organizations totaling \$919,892 and scholarships to students totaling \$138,700 in 2022. The Community Foundation's largest grants in 2022 were awarded to the MyMichigan Health Foundation, The City of Mt. Pleasant, and Christian Counseling Services.
